### Rights and Responsibilities: What you need to remember!

## You have the right to KNOW



How to protect yourself from hazards at work



If you don't know how to do something, ask for help

#### You have the right to SPEAK UP



if you are unsure about something or have safety concerns



Report unsafe working conditions to your supervisor – they are required by investigate



If no action, report to WorksafeBC

#### You have the right to REFUSE UNSAFE WORK



If asked to do something dangerous, tell your supervisor you won't do it



You cannot be fired or punished for identifying or refusing unsafe work


#### Your Responsibilities



Use all safety equipment, clothing and devices provided



Perform work in a safe manner





Follow all safety rules and regulations



Report anything that may be a hazard (to anyone)

#### Matthew Boycott's Story


#### Questions

- Why do you think Matthew was injured on the job?
- How will this injury affect him for the rest of his life? Could it have been even worse?
- How did his employer not fully prepare Matthew for his job in the kitchen?
- Could this accident have been avoided? How?
- Did the video change your view of kitchen work? What other jobs do teenagers commonly do, and what are some of the dangers they may face at those jobs?
- April 28<sup>th</sup> is the National Day of Mourning for Workers Injured and Killed on the Job. Why do you think we commemorating this day?





#### Strategies for Refusing Unsafe Work



#### Strategy #1: Ask Questions

#### Phrase concern in the form of a question

- "Is this safe to do?
- "What can I do to make sure I won't fall?"
- "How heavy is that?"
- "Do you think I might need someone else to help me lift it?"
- "Can you show me how to do this safely"

Be polite and, if possible, be friendly in your tone

This strategy less confrontational

#### Strategy #2: Use "I Feel" Statements

## Bring forward concerns/complains starting sentence with "I feel..."

- "I feel that it is too dangerous to use the bread slicer when the plastic blade guard is broken"
- "I feel that I would not be able to safely lift the box on my own because the label says it is almost 75 lbs."

Can argue about whether something is safe or not but can't argue about a person's feelings

No one can tell you that you don't "feel" safe

#### Strategy #3: Get Help

**m**i

Strength in numbers – voice concerns with other employees who are also worried Ask for help from Health and Safety Representative or shop steward/union representative


## If none of these strategies work... stand your ground
