RIEL FEARED CIVIL WAR

- Riel feared there would be a civil war in the Red River Settlement because John Schultz and the Canadian Party were already armed and prepared to attack the Metis
- Riel led a party of armed Metis to
 Schultz's home the headquarters of the
 Canadian Party



- Now, Riel declared he was ready to

negotiate with the Canadian Government.

JOHN A. MACDONALD WAS A TOTAL RACIST

- "We must not think of military force until peaceable means have been exhausted. Should these miserable half-breeds not disband, they must be put down".
- Riel and his temporary government drafted a proposal for the creation of Manitoba anyways.



IN THE MEANTIME...

Schultz escaped from Fort Garry and planned to free other prisoners

- But, before Schultz could attack his raiders clashed with the Metis and several of his followers were imprisoned

yet again.



THOMAS SCOTT


 One of these prisoners was Thomas Scott, the most belligerent member of the Canadian Party.

- In prison, ______

- He was brought to court in front of the Temporary government where it was determined he was guilty of defying authority, attacking his guards, and slandering Louis Riel.
- On March 4, 1870 he was executed by firing squad by Riel's temporary government.








THOMAS SCOTT A HERO AND MARTYR???

- The Orange Order created a myth around Thomas Scott
 - They said he had been cruelly murdered by the Metis for no reason
 - It didn't help that when the firing squad shot Scott, he didn't immediately die so the squad director had to go up to him and shoot him in the head.

- This fuelled even more hate for Riel and the Metis.



ADMISSION OF MANITOBA TO CANADIAN CONFEDERATION

- It was hard for the temporary government of the Red River to get recognized by Macdonald and his government
- But, in April Macdonald did admit Manitoba to Canada on these conditions:
 - A grant of 200,000 acres for the Metis to live on, while the Canadian government gets the rest of the land.





JUSTICE FOR THOMAS SCOTT

- Macdonald sent 1200 soldiers to Winnipeg to show his support to the people who thought Riel should be brought to justice for ordering Scott's murder.
- He told the soldiers to keep the peace until the transfer of power to a new provincial government could be made
 - They were not to treat Riel or the temporary government as being a legitimate government.

RIEL LEAVES, BUT MANITOBA STAYS FOREVER

- By the time the soldiers reached Manitoba, Riel had left the area because he knew his life was in danger.
- Eventually, all members of the temporary government that Riel had set up were let off of their crimes... except Riel!
- Riel spent the next 15 years in the United States.
